Clerk's comments on Auditor General report and opinion.

1 . The Council has not provided a copy of the Well-being of Future Generations (Wales) Act 2025 Report for 2023-24.

The Council did prepare a combined Annual and Well-being of Future Generations (Wales) Act 2015 Report and the Clerk believes that a copy of this report was supplied to the Auditor with the necessary papers for audit.

In future a separate Well-being of Future Generations Report will be prepared. The combined report has been published on the Council's website.

2. Approval of Standing and Financial Regulations.

The Clerk could not provide a copy of the Minute approving these standing orders because the necessary Minute Book was not accessible at the time of submitting the papers for Audit.

The Standing Orders and Financial Regulations were approved in the Council Meeting held on the 14 July 2003 and a copy of the Minute is now available.

A copy of this Minute had been provided to a previous External Auditor and there have been some four different external auditors in the last twenty years.

New Standing Orders and Financial Regulations will be put in front of Council in the near future.

3 . The Clerk's comments were sent to the Auditor on the 5 February 2025 but there has been no response to date.



Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Llangennech Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

Assertion 3 - compliance with laws, regulations and codes of practice. The Wellbeing of Future Generations (Wales) Act 2015 requires councils with income and expenditure exceeding £200,000 to report annually on how it contributes towards the well-being objectives for the area. The Council has not provided a copy of the 2023-24 report.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Approval of Standing Orders and Financial Regulations

The Council did not provide a copy of the minutes at which it approved its standing orders and financial regulations. This information was requested in the audit notice issued to the council in March 2024.

We recommend that before it submits its annual return for audit, it carefully reads the audit notice to ensure that all required information is submitted.
