1. Welcome

The Chair welcomed Councillor G Morgan and Mrs C Morgan, Chair elect of Llanelli Rural Council, Councillor P Warlow, Mayor elect of Llanelli Town Council, fellow members, including new members and guests to the Annual Meeting of the Council.

2. Review of the Year

Chair Review of the 2021/22 Year

Installation

Appointed Chair of the Council on the 17th May 2021 at a Zoom meeting. The event was a remote meeting of the Council because Covid 19 Restrictions were still in force.

The last face to face meeting of the Council was held on the 9th March 2020 at they Bryn Hall and the next face to face meeting was held on the 15th June 2021 at the Community Centre which meant a period of 15 months meetings had to held remotely.

b) The Council commissioned an independent review of all Council staffing resources, job descriptions, contracts of employment and to set out options for restructuring of the staffing establishment with supporting guidance along with a review of employment policies and processes including pension arrangements.

This was to be carried out by Mr Paul Egan, Deputy Chief Executive and Resources Manager of One Voice Wales.

This review has now been completed and a report produced and the Council is in the process of implementing recommendations in this report.

Covid 19 Restrictions

The Council was involved in considerable discussions during the year with users of its facilities, including sporting bodies requirement to have access to the pavilion with regard to use of the changing rooms and showers.

The Council spent £1,590 on the creation of a partition to allow changing rooms and showers to be brought back into use. It agreed arrangements to separate the hall, kitchen and ladies toilet from the changing rooms and showers areas so that risk assessment concerns were satisfied.

Environment/General

a) Blaenhiraeth Solar Farm Project

The Community Council had expressed its dissatisfaction with the community benefits offered by the developer. Letters were sent to the Planning Inspector, Solicitors acting for the developer and the local AM asking for reconsideration of the sums being offered.

A response was received from the solicitors acting for the developer which stated that due to costings and viability issues of the project the amounts offered would not be amended.

b) Footpath 35/35 – Heol y Parc

Resurfacing of the path was completed at a cost of $\pounds 2,736$ including VAT.

c) Japanese Knotweed Problem

The Council continues its work of employing contractors to remove this problem from Council owned land.

d) River Mwrwg

The Council employed contractors to clear vegetation from this river and will continue to do so.

e) Flower Baskets

The Council will continue with this service and employs Swansea City Council to carry out this on behalf of the Council.

f) Dog Fouling

This is a major concern of the Council both in general throughout the village and also in the recreation ground.

Various options have been considered and the Council will continue to take this on board.

Christmas Switch On

This took place on Saturday 4th December 2021 and it was a very successful night despite the fact that Swansea City Council withdrew their supply of the land train. A parade was organised at short notice and all involved need to be congratulated.

Planning Matters

Considerable discussion took place during the year on two planning applications in respect of traveller sites.

One application PL/00775 - creation of four family traveller pitches at Maesydderwen was approved on the 24^{th} June 2021.

The second PL/00333 - creation of ten additional traveller pitches to the west of PL/00775 is still under consideration and County Councillor Peter Hughes Griffiths attended a Council meeting on the 14^{th} March 2022 and he agreed to take back to the County Officers and Cabinet Member the concerns and observations of the Council.
